

**J. Elmore Hudson '30 Corps of Cadets History Scholarship
COPYRIGHT AND CONSENT FORM**

TITLE OF PAPER/ARTICLE/REPORT, INCLUDING ALL CONTENT IN ANY FORM, FORMAT, OR MEDIA (hereinafter, "the Work"):

AUTHOR (hereinafter, "Author"):

1. In consideration for being an active participant and possible winner of The J. Elmore Hudson '30 Corps of Cadets History Essay Scholarship (the "Scholarship"), Author hereby assigns to The Association of Former Students of Texas A&M University (the "The Association") the entire right, title and interest in and to all copyrights in and for the Work and agrees to execute whatever assignment of copyright and ancillary and confirmatory documents as may be required or appropriate to transfer exclusive title in the Work and any copyright in it to The Association. Author, and the minor's parent or guardian if indicated below, shall execute all documents and do all things necessary or proper to give full effect to the provisions of this section. In addition, Author, and the minor's parent or guardian if indicated below, hereby agrees to provide The Association with all original artwork from which the Work is derived. Author, and the minor's parent or guardian if indicated below, expressly acknowledges and agrees that execution of this Agreement does not guarantee Author as a finalist or winner of the Scholarship.
2. This assignment includes assignment of all the exclusive rights recited in Title 17, Section 16 of the United States Code, including, without limitation, the right to register claims for copyrights in the Work in the name of The Association, the right to reproduce the Work in copies, the right to prepare derivative works based upon the Work, the right to distribute copies of the Work to the public by sale or transfer, or by rental, lease, or lending, the right to publicly perform the Work, and the right to make audio or visual works incorporating or otherwise making use of the Work, as well as the right to authorize others to do any of these acts.
3. Author warrants and represents that Author is the author, originator, creator, and owner of all rights, including without limitation all copyrights to the Work, and has full authority under the law to make the assignment of rights as identified herein. To the extent the Materials incorporate text passages, figures, data or other material from the works of others, Author has obtained any necessary permissions to the extent possible. By executing the Agreement, Author confirms that the designs and/or verbiage submitted for the Scholarship is original and not copied from another source.

Author's submission of the Work in the Scholarship constitutes the irrevocable permission of Author, and the minor's parent or guardian if indicated below, to use Author's name, photograph, voice, likeness and background information (as provided by Author) as part of the advertisement, distribution and sale of products incorporating the Work, and releases The Association from any claim based on right of privacy or publicity. To the extent the Work is edited prior to further distribution or sale of products incorporating the Work, Author shall be afforded a reasonable period of time to review and to elect to remove attribution, by notification at the physical address and/or email provided below.
5. Author, and the minor's parent or guardian if indicated below, hereby consents to release by Texas A&M University of verification of enrollment for the semester which includes the date below.
6. Author, and the minor's parent or guardian if indicated below, hereby indemnifies Texas A&M University, The Association of Former Students, and the Houston A&M Club, and their officers, directors, employees, agents, and independent contractors from any and all claims, demands, or causes

of action that any third party may have against Texas A&M University, The Association of Former Students, and the Houston A&M Club and their officers, directors, employees, agents, and independent contractors, whether for copyright infringement, personal injury or loss, violation of any privacy, or any other matter arising out of or in any manner connected with the Work and Author's participation in the Scholarship.

7. Author, and the minor's parent or guardian if indicated below, hereby releases, discharges, and holds harmless Texas A&M University, The Association of Former Students, and the Houston A&M Club, and their officers, directors, employees, agents, and independent contractors from any and all claims, demands, or causes of action that Author, Author's heirs, executors, or administrators may have against harmless Texas A&M University, The Association of Former Students, the Houston A&M Club, and their officers, directors, employees, agents, and independent contractors, whether for personal injury or loss, violation of any privacy, or any other matter arising out of or in any manner connected with Author's participation in the Scholarship.

8. Texas A&M University, The Association of Former Students, and the Houston A&M Club are not responsible for lost, late, illegible, incomplete, damaged, mutilated, misdirected, misdelivered, or delayed entries, or for technical or human errors or failures of any kind in connection with the submission, transmission, processing, or judging of entries.

9. The Houston A&M Club reserves the right to cancel, terminate, modify, or suspend this project due to any of an act of God; unavoidable accident; epidemic; fire; blackout; act of public enemy; war, riot or civil commotion; enactment, rule, order or act of government or governmental instrumentality or tribunal; strike, lockout or other labor dispute; inclement weather; the recapture of any time period scheduled for the live broadcast of a program for an event of national importance or emergency; failure of technical facilities; failure of essential production, or technical personnel to appear or be available for production or broadcast; or other cause beyond its control.

The Association hereby agrees that to the extent the Work is incorporated in any product for distribution or sale, the profits attributable thereto, as determined by The Association in its sole judgment, shall be provided to the Office of the Commandant for the benefit of the Corps of Cadets. The Association hereby agrees the Cushing Memorial Library and Archives may retain an archival copy of the Work and hereby provides the Cushing Memorial Library and Archives a royalty-free license for reproduction of the Work of scholarly research. The Association agrees that the Houston A&M Club may reproduce, royalty-free, selections from each year's winning submissions.

11. The Agreement shall be governed by and construed in accordance with the laws of the State of Texas without regard to principles of conflict of laws. The venue for legal proceedings, if any, shall be in Brazos County, Texas.
